On 07-22-08 at approximately 0320 hours, Brian Wilkins was arrested at 1223 W. University Dr. #5, Tempe, for aggravated assault, disorderly conduct, possession of drug paraphernalia, and possession of marijuana. Investigation revealed Wilkins had an argument with victim and neighbor, Michael Wood, who then returned to his apartment. Shortly after, Wilkins exited his apartment and discharged his pistol into the air. Wilkins then contacted Wood in front of Wood's apartment and confronted him. Wilkins pointed the pistol at Wood's head and told him he was going to shoot him. Wilkins then walked back towards his apartment, fired two more rounds in the air, and went into his apartment. Wilkins was detained by police and a protective sweep of his apartment revealed a handgun, marijuana, and drug paraphernalia which were all in plain view. Wilkins was booked into Tempe city jail, held on the aggravated assault and disorderly conduct charges and was released pending on the drug charges.
