I said I am talking to my boss and I will not get off my phone! I do know my rights! Give me my ticket so I can get to work. He gave me my ticket and then followed me down to town center. I am a 40 something mother of 6 who has no record no accidents and I HAD no traffic violations! I am not saying that I was not speeding and that I should have gotten off...my point is that those officers used excessive verbal and emotional abuse on a law abiding citizen! I find it very believable that this iscommon practice in Bella Vista. We have just become a city and we have officers that I certainly could describe as Barney Fife with a mean streak! We will NOT accept this substandard justice."

"I got stopped last winter in Benton county for a crack in my windshield and when they ask for my registration I got in my console to get it when the officer seen a cheesecracker wrapper in there and they made me get out of my car while they searched my car for "drugs" that I don't use. That was very humiliating standing there like I was a criminal on 540. They was just jumping to conclusions again. Should have I been shot too just because they thought I was doing something wrong. It makes it scary when they do pull you over."

"Most cops are hard working and do their best at trying to keep the peace. There are, however, many who wear a badge that are nothing more than jack booted Nazis with an extreme attitude. The public is the enemy to them. I personally do not trust either BVPD or ASP to investigate this."

"I live in the village and though I haven't seen the type of public outcry that we see on this forum, it is a definitely a topic of conversation among my friends and neighbors and those in othercommunities. They are curious, but an overall distrust of our PD is developing. Not just from this single instance. I think most of us have heard talk about the increased police presence, traffic stops, officers speeding on side streets with no lights, hiring of an officer who was expelled from the police academy. Instances such as these cast a bad light on the BVPD. Part of these issues began before Chief Farmer took control (Having lived near our former Chief, Jim Wozniak and having nothing but respect for him I was concerned and confused by the police academy issue. Frankly, still do not understand that decision)"

"As for the damage that this is causing I can assure you that this is just the kind of bad publicity that can drive business away. There are plenty of places for people to play golf. I don't want to see BVPD to earn the same reputation as the police departments in Elkins, Cave Springs or those eastern Oklahomacommunity police departments that were raided by the FBI a couple of years ago."

"So even if it is agreed that the use of a weapon was warranted, why would an officer professionally trained to react in stressful situations; one skilled in the use, care, and application of a handgun and all other applicable weapons; one physiologically and psychologically tested forcompetence; one educated in law, policy, process, and tactic; one sworn to protect life; why would this individual unload 4,5,6 rounds into Mr. Ahern. What I'm asking is why not fire one round into his shoulder, or perhaps reposition and shoot his leg or lap. Most people never have or never will be shot. Having said this, I am quite confident that the shock of realizing that somebody just shot you would be enough to subdue anyone. Albeit there was certainly chaos abound after the crash, the cop had the time to consider the actual effect of his gunshot. To kill or to maim? He could have just shot out the back window for that matter. Surely that would be startling enough! The laws of physics would suggest that there is never the need to apply any more force than

is necessary to achieve the predetermined result. Which would suggest that at some level the cop wanted to barrage the victim or kill him, even if this decision did arise from temporal fear or hostility generated from stress or subconscious precondition."
